GTC ANNOUNCES COMPLETION OF FIVE (5) PARKS AND RECS PROJECTS IN 2015—MORE TO COME IN 2016

From Playing Fields to Playgrounds, Lap Lanes to Lazy Rivers, Construction Firm Helps Recession-Rebounded Communities Enhance Their Summer Fun

Golden Triangle Construction (GTC) announces the successful completion of five recreation-related projects in 2015, which covered the spectrum from multi-surface playing fields to all-out aquatic parks. The number of parks and recreation projects marks a rise from recent years, seeming to signal a return to a healthy economy where local municipalities can once again afford major improvements to their parks systems.

Two projects were completed for the City of Aurora. Del Mar Family Aquatic Center included a bathhouse, a 25-meter pool with a diving well, a water playground, waterslide, lap lanes, and a concession stand. The Del Mar Family Aquatic Center was designed by Ohlson Lavoie Collaborative. GTC also finished a 17.5 acre expansion project to the City of Aurora Parks, Recreation and Open Space (PROS) Dept's 220-acre Sports Park. The expansion included the installation of four, lit, multi-sport synthetic turf fields, a concrete seat wall surrounding the fields, a vending kiosk, fully-plumbed and heated restrooms, and landscaping. Aurora Sports Park was designed by DHM Design.

GTC also completed two projects for the City of Commerce City. Fronterra Park is an 18.5 acre park which includes playground, shelters, restrooms, trails, and a skate area. Paradice Island Pool at Pioneer Park is a new outdoor leisure pool and bath house with features including kiddie pool, slide tower and lazy river. Fronterra Park was designed by DHM Design; Paradice Island Pool at Pioneer Park was designed by Ohlson Lavoie Collaborative.

In addition, GTC handed over the keys to a new facility in Fort Collins. The <u>Kechter Farms Community</u> Clubhouse included a new 6,500 square foot neighborhood clubhouse, featuring a state-of-the-art fitness center, yoga room, and event and outdoor entertainment areas. The pool is approximately 39,000 square feet, with water features and a spa. Site work also included utilities, BBQs, a pergola, a playground, and a gas fireplace. Kechter Farms's Clubhouse was designed by Vaught Frye Larson Architects.

GTC was pleased to be awarded these projects. "It's always satisfying to build recreation projects," said Brian Laartz, President of GTC. "Knowing that you're creating places where people can relax, play, have fun—that's fun for *us*."

And the fun goes on: GTC is excited to begin work in 2016 on renovations to turn a pool into a water park for the City of Lafayette. The Lamont Does Aquatic Park, designed by Ohlson Lavoie Collaborative, will feature slides, a lazy river, and play structures. The park is scheduled to open to the public by spring 2017.
